ASSESSMENT ONE:

-Complete at least 25% of the "READINGS" (50%) and take the "OBJECTIVE TEST" (50%)

In this case, the marks resulting from the two methodologies will be added up, IN THE JANUARY ASSESSMENT AND IN THE JULY ASSESSMENT.

If the totals of the two methodologies do not equal to a pass in the January assessment, the results obtained in the "READINGS" will be considered, and added up to the results obtained in the "OBJECTIVE TEST" in the July assessment.mail: maria.romani@udc.es
