CALCULATION OF THE FINAL GRADE OF THE COURSE: Each Branch has a proportionate weight in the final grade, namely: Public international law - 78% of the final grade; Constitutional law - 15% of the final grade; and Procedural law: 7% of the final grade.

BILINGUAL DEGREE: In relation to the part of Public international law, the final exam of the Course will be written. It will represent 40% of the final grade and the other activities will mark 60% of the final grade.
