<b>General description</b>	<p>Globalización económica e desenvolvemento social é unha materia optativa dentro da especialidade de Economía e Sociedade. Preténdese que o alumnado desenvolva destrezas para diferenciar os elementos relevantes nos procesos de globalización, identifique as súas consecuencias e valore as distintas opcións de política económica e social. Para iso, analizaranse casos concretos de estudo sobre os que o estudante deberá realizar avaliacións, diagnósticos e valoracións das distintas posibilidades de acción para afrontar os retos sociais desde unha perspectiva económica.</p>
