Assessment comments

Para o recoñecemento da cualificación por asistencia a eventos, o Decanato facilitará unha relación de matriculados que deberá asinarse no acto celebrado. Aqueles alumnos que non puideran asistir por causa debidamente xustificada deberán achegar os documentos que acrediten a dita xustificación, e deberán facelo como data límite de recepción do informe do tutor profesional.

O número de eventos non será superior a 12 nin inferior a 4, ao longo de todo o curso académico.

Para o cómputo da cualificación elixiranse aleatoriamente 4 das probas celebradas, tendo prioridade as presenciais. Cada unha das 4 probas seleccionadas puntuará 0,5 puntos, polo que a asistencia a todas elas garante unha nota de 2 puntos, o que supón o 20% da nota máxima alcanzable.
